#### Abstract -

The pre-1800 settlers of Western Virginia (Augusta County at that time) included at least ten different Scots-Irish "Sproul" families. Their names were variously spelled Sproul, Sprowl, Sproule, Sprouls, and Sproull. Most of these families dispersed throughout our developing country in the early 1800's, settling in Kentucky, Tennessee, Ohio, Indiana, Missouri, and Texas. This genealogy documents those ten families and provides source reference documentation and records on their early period. The family of the Settler William Sproul of the Cowpasture River and later, Moffatts Creek, is addressed in great detail in a separate document, *Sproul Family of Early Augusta County, Virginia – the Middlebrook William Sproul Family*.

#### Purpose of this Genealogical Collection -

The purpose of this genealogical collection is to identify the various "Sproul" families of Western Virginia and provide the descendants of those early Scots-Irish settlers with a solid and documented basis for conducting their genealogical research from this point of settlement in the colonies before these families multiplied and spread so rapidly westward. As many genealogical documents as possible are contained in this collection and directly accessible throughout this website.

Errors in data and its interpretation are already present in our genealogical references, and some will undoubtedly be repeated in this collection. Readers of this material are requested to send in any corrections and comments on accuracy or conflicts as well as additional new data items.

**Section 1 - Early Western Virginia "Sproul" Families -** Section 1 presents an introduction to the early settler families, their identification, a physical location map, and a chronological listing of parallel families and names.

**Section 2 - Ten "Sproul" Settler Families -** Section 2 contains the detailed description and all reference documentation of that is known of the ten families, excluding the details of the Middlebrook Settler William Sproul Family.

#### Introduction

The first explorers crossed the Blue Ridge Mountains to the Valley of Virginia by about 1716. The **Early** settlement of Western Virginia began soon thereafter with many settlers crossing the Blue Ridge to enter the Shenandoah Valley in the early 1700s, somewhat before Augusta County was established in 1745. This early time frame nominally extends to 1800.

Western Virginia during this period may be defined as the vast original area of Augusta County when it was established in 1745. This Virginia county bordered the Blue Ridge on the East, extending south to North Carolina, west to the Mississippi River through what is now West Virginia and Kentucky, and north to include much of what is now Ohio, Indiana, and Illinois. Early "Sproul" settlers were found in many of the Virginia counties subsequently established in this area including Augusta, Rockbridge, Bath, Botetourt, Wythe, Washington, and Highland Counties. This vast area is shown so vividly in the Early Augusta County map by Hotchkiss below.




Figure 1 - Early Augusta County, Virginia

When established in 1745, the vast area of Augusta County extended South along the Blue Ridge to the North Carolina border, West to the Mississippi and rather indefinitely Northward.

Among the early Scots-Irish settlers of this Western Virginia area were the numerous **Sproul, Sproul, Sproul, Sprouls**, and **Sprouls** families. With the use of common first names and more than twenty spellings and misspellings of the last name, there is often confusion over the attribution of specific records to actual individuals and families. The Washington County records, for example, show twelve different "Sproul" spellings in what appears to be a single family.

Presented herein is a compilation of early records providing an initial identification and separation of ten early "Sproul" families. There still remain numerous "Sproul" records which appear ambiguously applicable

to several families or apparently not applicable to any of the families as now defined. As more records become available, certainly a clearer picture will emerge.

#### Ten "Sproul" Settler Families

At least nine unique "Sproul" settler families have been identified, with probable elements of a tenth family. Figure 2, *Nine Early Families*, shows a picture of the nine families, graphically mapping these families, the settlers and their children, against time. All of these families seem to be of Scots-Irish origin. While most of these families appeared in the same locale at the same time and many share similar given names, so far there is little evidence of the family relationship between these immigrant families. Being Scots-Irish generally means these families were of Scottish origins, and participated in the plantation of Ireland in the 1615 to 1630 time frame. These Augusta County families then emigrated to the American colonies in the 1800s.

Figure 3 is a map of today's Augusta, Rockbridge, Bath and Highland Counties of Virginia, indicating where the early "Sproul" settlers located, and including their paths of movement from one location to another. Shown here are the locations of the first four "Sproul" settlers, all arriving within a five year period after 1751, and then another three by 1784, all within or near today's Augusta County, Virginia. This figure reveals the emerging picture of seven Scots-Irish Sproul settler families closely grouped in an area between Staunton and Lexington, Virginia. Today, there is but one of those families still resident in the area.

Recognizing that there are numerous unique "Sproul" families in the same area at the same time using similar given names is important when attempting to attribute recorded events to specific individuals and families. For example, there are at least nine William and seven John "Sproul" in this period, and the identifying family name is frequently misspelled, illegible, or garbled in this early period.

Family folders have been established for each of the ten identified early "Sproul" settler families and are addressed in Section 2. These contain a genealogical sketch showing their first two or three generations as may be available and then whatever records have been associated with that family. Occasionally, images of documents such as wills or marriage bonds, which are highly informative prime sources, are noted and made available online.

Briefly, the Ten Early "Sproul" Families are:

William Sproul of Cowpasture River and Moffatts Creek settled first on the Cowpasture River in today's Highland County and later moved to the head of Moffatts Creek between Staunton and Lexington. This 1756 Scots-Irish settler is forefather of the current Augusta County Sproul family, some of whom still reside at his "Locust Grove" homestead near Middlebrook. With his first wife, Jane, and second wife, Susanna Ewing, there were fifteen Sproul children. Many of these children and grandchildren moved westward to settle Tennessee, Ohio, Kentucky, Missouri, Texas, and elsewhere. Descendant lines from these dispersed ancestors have been found and extensive documentation on the Middlebrook Sproul family is available.

**John Sprowl of Jackson River** appeared in 1753, settling first in Augusta County in the Bordon Tract near today's Brownsville and moving to the Jackson River of today's Bath County in about 1770. John and his wife Margaret had four daughters, several marrying into families of the area, and five sons whose descendants have not been located.

There is a possible family relationship suggested between this John and William of Locust Grove by there being six children names in common. A relationship could also be suggested with this John and William of Rockbridge, their using the same "Sprowl" spelling and sharing four common children names. This John did move on to the Jackson River, however, probably about the time that both of the two possibly related William's arrived in the near vicinity of John's original Beverly Manor location.

**Samuel Sproul on Back Creek** was among the earliest "Sproul" settlers, first recorded as purchasing 210 acres on Back Creek in the Beverly Manor of Augusta County in 1753. Samuel was also probably the oldest early settler, in 1763 being "exempted from levy due to great age and infirmity." Samuel died in 1773, leaving his wife Margret and three married daughters. No male offspring have been indicated.

**Broad Springs John**, perhaps the earliest "Sproul" settler, showed up in 1751 but may not be a Sproul at all, although frequently listed as such. With the final "t" often not crossed in the script of the day, "Sproul" and

"Sprout" often become indistinguishable. At any rate, this John died in 1755 and his wife withdrew the family from the colony. This John "Sproul" settled in the Bordon Tract in approximately the same year and within a mile or two of John Sprowl of Jackson River.

William Sprowl of Rockbridge, an Irishman and former British soldier is first noted in Western Virginia purchasing 323 acres of land in 1771 on a bend of the North Fork of the James, now called the Maury River, about 6 miles north of Lexington. He had about ten children, most of whom moved to on Preble County, Ohio in the early 1800's. One son, William, remained in Rockbridge County until about 1840 before joining the others.

**James of Augusta and Rockbridge Counties** arrived and acquired land adjacent to Settler William's Locust Grove in 1773 suggesting a possible family relationship. James and Catherine were married in 1786. They sold their land and possessions and moved to Kentucky by 1800. No offspring have been noted.

**James Sprouls of Washington County** settled along the Holston River and Abram's Creek in about 1770. This family has not been well sorted or documented yet. Recently found census information gives much more detail of the second generation of this family, but little identity of the settlers. Variations on spellings in Washington County documents for this family include Sprouls, Sprowl, Sproules, and Sproule.

**John Sproul of Dry Branch** at the Jackson River is first noted in 1784. Surveyor and school teacher, he left his alleged feeble-minded wife in Ireland. Bridgett, however managed to catch up with him teaching school along the Jackson and, reunited, they raised numerous offspring, the daughters marrying into families still in the Bath County area, and the sons, apparently, moving on.

**William Sproull of Wythe County** married Elizabeth Cooper in Ireland about 1776. They arrived in Wythe County, Virginia in 1793 with six children. This family has good documentation and traces to the present descendants.

**Samuel "the Unknown"** was active in the area in the 1770's and 1780's but appears to have left before 1790. His participation with other Sprouls in legal, military, and marriage events define him to be a known friend, but no picture has emerged of his location, family, or eventual residence.




Figure 2 – Nine Early Families in Augusta County and SW Virginia – Sproul, Sprowl, Sproule, Sprouls, Sproull




Figure 3 – Early "Sproul" Settler Locations

All known references and early records are included to establish the identity of each family and provide the basis for further research. Some of the data contained in these Section 2 descriptions is from family and web-based sources not well-supported with verifiable documentation. Family members and readers of this material are invited to provide additional reference sources wherever it is available.


Only a short record of William Sproul of Cowpasture River and Moffatts Creek is given here because a separate document, the *Sproul Family of Early Augusta County, Virginia – the Middlebrook William Sproul Family*, is devoted entirely to that family.

This Scots-Irish William Sproul was the progenitor of the current Sproul family of Augusta County, Virginia. With numerous offspring and an expanding frontier, the family spread rapidly across the country in the early 1800s. Of the fifteen second generation children, all seven daughters stayed in the local area but five of the sons moved to Kentucky.

# John Sprowl - Settler of Bordon's Tract 1753, then Jackson River 1770 1721?-1796 Wife - Margaret

John Sprowl was born in County Tyrone, Ireland in 1721. He married Margaret Paul who was born in Scotland 1739<sup>1</sup>. (Name spelled Sproul often in earlier records but later Sprowl.)

#### First Augusta County Records of John Sprowl in 1753 -

- Communicant at Timber Ridge signing call of Rev John Brown about 6 mi. NE of Lexington
- Purchased 194 acres in Beverly Manor {on SE Bordon Tract line}
- Purchased 285 acres on drafts of James {nearby just to the South in Bordon Tract}
- Road worker from North Fork of James {now Maury River} to Renix Road
- Road worker from Edmonston's Mill to Fork Meeting House

#### Location -

In 1753 John purchased land both in the lower area of Beverly Manor on the Bordon Tract line near Halfway Creek on a parcel first patented to William Robinson (194 ac) and a nearby 285 acre parcel in the Bordon Tract. He sold the Beverly land in 3 years but kept the Bordon land for at least 17 years, so most certainly lived there. He also bought another 250 acre parcel in 1768 in Bordon Tract but held that for only a year. These parcels may be located on the respective tract maps: Beverly Manor 1736<sup>2</sup> and Bordon Tract 1739<sup>3</sup>

John and Margaret moved on to Jackson River in 1770 to 85 acres on the Jackson River {now in Bath Co}, known by name of "English Place." This was purchased by John Sproul and wife Margaret for £20

John and Margaret Sprowl bought two parcels of land in 1753, located about six miles apart. One parcel of 194 acres was in Beverly Manor on the southern border adjacent to the Bordon Tract. This was part of the 1749 William Robinson 380 acre parcel shown on the Beverly Manor Map. This land was sold three years later.

Although Broad Springs John was the earliest recorded "Sproul" settler, he perhaps was not really a Sproul although his records were often written as Sproul and distinguishing a non-crossed final "t" versus a final "l" is difficult. John Sprout had arrived in Augusta County by 1751 and died in 1755, leaving a young family including two infants, all of whom soon left the colony.

John's 320 acres has not yet been precisely located, but the short Broad Spring Run is within two miles of Settler William Sproul 1765 purchase of Locust Grove and also within two miles of Jackson River John Sprowl's 194 acres purchased in 1753 and his 250 acres purchased in 1758.

William Sprowl – 1771 Settler on North Fork of the James River b. Ireland, d. 1798 - Rockbridge Co. Wife - Elizabeth Lusk, m. 1773

There is a great deal of information on William Sprowl, not all of which has source documentation and much of the documented data has not been fully compiled into a family genealogy. William settled on a bend of the North Fork of the James (now the Maury River) in 1771, about 12 miles south of where William Sproul of the Cowpasture and Moffatts Creek settled at approximately the same time. The records of these two are particularly confusing since many of the early William Sproul records were recorded as William Sprowl and vice versa. Both also had sons and grandsons named William. These families still vie for claim to the June 23, 1773 Augusta County marriage license which can only really belong to one of them. Jackson River John Sprowl lived slightly east of halfway between these two William's but moved 50 miles away to the Jackson River area about the time they arrived.

William Sprowl came to America from Ireland as a soldier in the British army, and took part in the Battle of Quebec during the French and Indian war. After this battle he was left to do guard duty in that city, where he continued until the expiration of his period of enlistment. Instead of returning to his native country he remain in America, and some time after receiving his discharge he went to Norfolk, Virginia, thence a little later to the town of Lexington in the same state. There he purchased a tract of 323 acres on the North Fork of the James River in 1771 and entered upon the duties of farm life. He married Elizabeth Lusk in 1773. 10

William and Elizabeth had ten children. After William died in 1798 in Rockbridge County, the family began their westward move, to Ohio, Indiana, and Illinois. The land on the Maury River was sold in 1806 and most of the family moved to Preble County, Ohio. Son William and his family were the last of the children to have relocated in Ohio in 1841.

William Sprowl came to America from Ireland as a soldier in the British army, and took part in the battle of Quebec during the French and Indian war. After this battle he was left to do guard duty in that city, where he continued until the expiration of his period of enlistment. Instead of returning to his native country he concluded to remain in America, and some time after receiving his discharge he went to Norfolk, Virginia, thence a little later to the town of Lexington in the same state. There he met and married Elizabeth Lusk, and within a few years became a large land owner, purchasing a tract of three hundred acres in the bend of the James river, and entered upon the duties of farm life.

William and Elizabeth Sprowl were blessed with a family of ten children, five sons and five daughters, one of the sons, Joseph, marrying, on the 14th day of April, 1814, Miss Jennie Armstrong. In October of the same year this couple took up their residence in Preble county, Ohio, and in 1834 moved to the new and sparsely settled region of Huntington county, Indiana, located near the site of Lancaster in the township of the same name. They were the first permanent settlers in that part of the county, and did much toward developing the country and inducing other families to locate in the same neighborhood. They had a family of eight children, one of whom, Robert by name, married, August 1, 1849, Hannah Shaffer, a daughter of John C. and Sarah Shaffer.

# James Sproul - 1773 Settler of Augusta and Rockbridge

James first appears the area in 1773, acquiring two parcels adjacent to Settler William on Moffatts Creek – 80 acres to the North and 193 acres to the West. This land is identified on the Bordon Tract Map in the section on Settler William's Moffatts Creek Land. Sec. 3.4.3.

There are several references to this James of Augusta County over the next ten years including serving in Capt McCutchen's Augusta County militia company along with Alexander and Samuel Sproul in about 1777 and also being teste at a Tate/Newlan 1787 marriage along with Samuel Sproul and James Beard.

In 1784, James purchases 283 acres in Rockbridge County from James McChesney. The following year it is noted in the Tax Alterations list that James Sproul's Augusta Co land (300 acres although purchase of only 273 acres has been noted) had been transferred from James Sproul to James McChesney, suggesting a land exchange between Sproul and McChesney. The 283 acre Rockbridge parcel has not yet been located.

James Sproul of Rockbridge married Catherine in 1786.

There are several more Rockbridge County references to James, but in 1789 he either was in debt or needed a loan, because he pledged all his stock, grain in the fields, furniture, bedding, and even wearing apparel against a one year obligation for £45.

In 1795 James and Catherine sell their Rockbridge County land to John Thomas.

James and Catherine next appear in numerous records in Gallatin, Kentucky, perhaps as early as 1796 and certainly by 1800. James was Deputy Sheriff and owned a considerable amount of land there.

No birth date, birthplace, or death record found. No parents, siblings, or children found. His will might be in Gallatin Co, Ky.

James is suggested to be related to Settler William (brother, cousin, nephew?) by his acquiring adjacent land in 1773, his serving in the militia in 1777 with Alexander and Samuel, and by his role in the Tate marriage along with Samuel Sproul. It should be noted that the Samuel Sproul of these references is unidentified and is not one of the currently defined settlers or their sons.

# James Sprouls – 1770 Settler of Washington County, Va

There is plenty of Washington County land, census, and marriage data but a good early family picture has not emerged. The land data ties this family together; land along the Abrahams Creek, south branch of the north fork of the Holston River. The census records present the picture of an early and large family with several branches. The family name spellings are so uniquely different in almost every record that it challenges explanation. At least twelve different last name spellings are found, some differences even occurring within a single record.

James Sproul appears to be the original settler here, first acquiring land along Reed Creek in Wythe County in 1769 but moving directly to Washington County. The wills of Samuel Sproles in 1839 and John Sproles in 1841 provide listings of some family members, <sup>14</sup> but this is will after the early settlement period.



#### CHAPTER XV

#### SCHOOLS AND THE PROFESSIONS

Early Educational Conditions - School Districts of 1848 - Schools of the Period - Teachers - Academies - Higher Education - Attorneys - Physicians - Authorship - Political Parties.

A S to when and where the first schoolhouse in Highland was built we have no knowledge. Until within the recollection of people still living our educational history is well-nigh a blank. However, it is safe to assume that it would be a meager chapter if known.

The earliest teacher of whom we have knowledge was William Steuart, progenitor of the Steuart family. He taught quite regularly from the time of his arrival about 1755, and appears to have been well educated, especially in the mathematics. Another early pedagogue was John Sprowl of Ireland, who was teaching at his home near the mouth of Dry Branch about 1790. He was also a surveyor. It is related of Sprowl that he had wedded in Ireland a feeble-minded woman whom he thought it best to leave behind. Yet while at his vocation he was one day thunderstruck to see Bridget Sprowl step into his schoolroom. The teacher accepted the situation and thenceforward lived with her. But several of their offspring were blighted with the inheritance of a weak mind.

# William Sproull - 1793 Settler of Wythe Co, Virginia d. 1799 Wife – Elizabeth Cooper

**William Sproull** of Scotland married **Elizabeth Cooper** in Ireland around 1776. The family immigrated to America in 1793 headed for North Carolina. Their ship was taken to Baltimore, Maryland, and from there, they eventually traveled to Wythe County, Virginia where **William Sproull** purchased land from **Thomas Marrs** on the Peek River near the present day location of Newbern, in Pulaski County, Virginia.

William and Elizabeth Sproull had six children: Robert, Heazlet, Rosannah, Margaret, Jane and the last Mary Polly, who was born in Virginia in 1798. William Sproull died in Virginia in September of 1799. Elizabeth Cooper Sproull died in Wythe County, Virginia in April of 1816.

Robert Sproull married Rachel Montgomery, the daughter of Joseph Montgomery and Rachel Ramsay, around 1804 in Montgomery County, Virginia. Their children were Susannah, Rhoda, Joseph, Stephen, Heazlett, Virginia, Robert, Anna, Elizabeth, Louisa and Placentia Sproull. Robert and Rachel moved their family from Wythe County, Virginia in the 1820's to Adams County, Ohio.

Heazlet Sproull married Elizabeth Fergus, the daughter of Francis Fergus and Mary McCormick of Wythe County, Virginia. Their children were Eliza, Mary, Francis, Elizabeth, Anna, and Robert H. Sproull who was born in 1816 after his father's death. Elizabeth Fergus Sproull remained in Wythe County, Virginia until after 1830. She married Joseph Montgomery, the brother of Rachel Montgomery of Wythe County, Virginia in Lafayette County, Missouri in 1835.

Eliza Sproull (1806-1865) was born in Wythe County, Virginia and married Hayden Bowler. They had two Bowler sons; Thomas Francis and Henry Hayden. Eliza Sproull Bowler moved to Missouri and married Ashley Duncan in Howard County, Missouri in 1832. They had eight Duncan children; Prior White, Jesse Riddlesbarger, Lavalette Elizabeth, James Caswell, William Patton, Rush Floyd, Tyson Dines, John Ashley, and Robert. She reportedly died 1865 in Montana where her sons Thomas and Henry lived at the time. The Duncan Family is well recorded.

Mary Sproull was born in Wythe County, Virginia. She married Jesse Riddlesbarger 1827 in Wythe County, Virginia. Their children were Heazlett M., Madison Maitland, James H., Harriet N., Robert C., Sarah E., William P., John P., and Rufus Zachary. Both Jesse and Mary Sproull Riddlesbarger died in Missouri.

Francis Sproull was born in Wythe County, Virginia and married Lucy Williams in Missouri. Their children were Robert, Susan Elizabeth, Mary M., and Joseph Montgomery Sproull. Both Francis and Lucy Sproull died in Missouri.

Elizabeth Sproull (1812-1870) was born in Wythe County, Virginia and married Peter Ball Cockrell, the son of Peter Ball and Sarah Smither of Virginia in Howard County, Missouri. Their children were Mary, John, Hazelett, Nancy, Eliza, Sarah, Lucy, George, and Alice Cockrell. They were all born in Missouri. Elizabeth Sproull Cockrell is buried in Missouri.

**Anna Sproull** was born around 1812. She may be a twin to **Elizabeth**. It is not known if she reached maturity.

**Robert Hazelett Sproull** (1816-1895) was born in Wythe County, Virginia after his father died that year. **Robert Sproull** was a resident of Henry County in 1834. He married **Margaret Robinson**, the daughter of **Cyrus Robinson** and **Lucinda Charlton** of Wythe County, Virginia, who resided in

Rivas County, Missouri in 1840. Their children were **James, Cyrus** and **Harriet Sproull**. **Robert Sproull** married **Margaret's** widowed sister, **Juliet Robinson Burke** after 1850. Their children were **Mary, John,** and **Abigail Sproull**.

Margaret Sproull married Mathias Hines, of Lee County, Virginia about 1807 in Wythe County, Virginia. Their children were Hazlet, Mathias, Andrew, A.F., John, Elizabeth, Rosannah, Anthony, Margaret, and Susan Hines. They migrated to Alabama before 1830. Mathias and Margaret Sproull Hines both died in Alabama.

**Rosannah Sproull** married **John William Russell** in 1803 in Wythe County, Virginia. Her mother's will states **Rosannah** was married to a **Mr. Lenty** prior to 1816. No other information is known about **Rosannah** at this time.

Jane Sproull married Mr. Owens prior to 1816. It is believed they remained in the Newbern, Virginia area.

Mary Polly Sproull was born in Wythe County, Virginia in 1798. She married **Joel D. Chrisman**, the son of **Gabriel Chrisman** and **Jane Cox** of Virginia in 1817 in Lee County, Virginia. Their children were Chelnessa, Elizabeth, Gabriel, Eleanor, Izza, William McConnell, Campbell Ewing and Rebecca Chrisman. This family traveled the Oregon Trail in 1844. **Polly Sproull Chrisman** died in Oregon in 1852.
